This grant proposal will support the first stage of developing a comprehensive Land Conservation Plan to guide our future decisions concerning protecting environmentally significant natural resources and open spaces in Atkinson.

We are forming a Working Group of both Conservation Commission members and the community at large, whose sole focus will be to listen to our community, set reasonable goals for land conservation, and establish criteria to use when setting priorities for protecting specific pieces of land.

This first phase, for which we are currently seeking your help, will enable us to hire a technical assistance provider to help define what this conservation plan needs to address, identify and vet qualified individuals to work on it, and support a second phase of grant applications once the scope of the plan and budget are better understood.

(How) Does your proposed project have environmental, social and/or economic impacts? Please describe how your project is contributing to a shift toward procedures and strategies that ensure ecological and social well-being, cooperation and regeneration in your community. In recent years, several large unfragmented blocks of land have been developed with clustered residential housing with open space that is only available to residents of the development. As a result, there is an increasing outcry to "fight back" to protect environmentally significant tracts of land and make them available for public use before they are gone forever. While we have approximately \$510,000 in a Conservation Fund that is restricted to purchasing land or easements, we do not have a plan for how to identify and prioritize the most important lands for protection. We don't even have a good idea what such a conservation plan would look like.

Over the past 20 years, residents have consistently voted to maintain funding for our town's Conservation Fund. The Land Conservation Plan would guide the town on how to spend it wisely.

We:

Provide a focal point within the town for environmental concerns. Be an advocate for the conservation of our natural environment. Raise public awareness of the benefits of open space in our town.

Serve as an advisory board to the NH State Wetlands Bureau and the Atkinson Planning Board and Zoning Board of Adjustment for development proposals and applications for zoning relief.

Manage the Town Forests, as authorized by RSA 31:112 and numerous Town Meeting votes, including but not limited to periodic selective logging, invasive species control, and establishment of public use regulations.

Inspire, organize, encourage, advise, and educate conservation-minded residents to help maintain the town's conservation trails, and provide signage, blazes, maps, and interpretive markers to facilitate the public's use and enjoyment of our open spaces.

Actively seek out opportunities to further protect our dwindling open spaces and groundwater resources, including but not limited to purchasing land, or

conservation easements to land. Where possible, look for grants to augment our town's Conservation Fund.

Help town residents understand wetland zoning and state regulations, and advise homeowners with questions about their property, especially those private lands that abut conservation lands.

Support Scout Troop 9 and similar organizations by providing opportunities, guidance, and modest funding for Eagle Scout and other conservation-related public service projects.

The Conservation Commission meets on a regular basis – usually the first Monday evening of each month. Our meetings are open to the public, are televised, our agendas are posted ahead of time and our minutes are posted on the town's web site. We follow a strict policy of having open meetings, and I actively discourage "email meetings" in which issues might be discussed without public visibility. As Chairperson, my management style is to encourage input from all members, as well as the public, and to work towards forming a consensus on issues.

What lived experiences do current decision-makers offer that will help with the project? Among our core members we have a surveyor, a retired biologist, several engineers, and several members with corporate management backgrounds, myself included, who are good at organizing and motivating groups of diverse individuals.

Since taking over as the Commission's chairperson about a year ago, I have been working to improve our communications with the community.

We have formed a very active Facebook Group – on Facebook, search for 'Atkinson Conservation' – on which we post information about our trail system, and updates about volunteer opportunities to visit and care for our trails. One very common remark to such postings is "I didn't know that!' Our Commission meetings are televised on the town's community access television channel, and we are developing a loyal group of followers. I make regular appearances at Selectmen and Planning Board meetings – also televised – to give them and the community updates about our work. And, with a few other members, I've begun to hold "office hours" one Saturday morning a month at our library just to make it possible for community members to come in and chat in an informal way with their questions and ideas about the town's conservation efforts.

Describe how the group makes efforts to understand and address barriers to participation in this project. +

We are interested in understanding how the group advances (or plans to advance) equitable access to resources, events, information and participation in the project. Our largest barrier to participation seems to be people's time, and their perceived inability to commit a large amount of time to a land conservation project. In response, we are trying to engage a broad range of individuals, with the thought that "many hands make light work" will encourage more people to participate, or at least add their voice.

Another impediment is expertise. I have been on the Conservation Commission since 1998, and I feel very inadequate to do the environmental studies necessary to assess the value of potential additions to our town's conserved lands. Others in town have even less experience, and so are hesitant to get involved with something for which they are inadequately prepared. Our response to this is to admit that we need to "hire out" much of the preliminary planning work and technical parts of this study to one or more qualified environmental scientists who do this sort of thing for a living.

Will this project build upon previous or parallel efforts (either initiated by your group or by others) or is this a new organizing strategy for the community?

While the Conservation Commission has had a long-standing goal to protect environmentally valuable lands in town, this actual planning work is a new initiative. We have come to realize that "purchase as much as we can and spend as little as possible" is not a plan, and we need a much more targeted yet broadbased, community-led planning effort to help us quantify the conservation values we should be looking to protect, and what the priorities should be before we consider individual pieces of property.

How does the group plan to learn about the project's impact(s) and understand whether this project's continuation meets a need within the community?

We have the first of hopefully many Public Forums already scheduled for Thursday, May 2, 2019, in our town's public library. We chose the library for its good meeting space, and to separate our efforts from "town government." We really want the Land Conservation Plan to be a community-driven plan.

During this first Forum, we will host a presentation by Julie LaBranche from the Rockingham Planning Commission, who will speak on what a Land Conservation Plan should address, and the overall process for accomplishing such a plan. A goal for the evening will be to define a draft list of the community's priorities for Land Conservation. Our town's Master Plan supports development of a conservation plan to protect important environmental and cultural resources and to expand recreational spaces for residents and visitors.

Other Public Forums will be scheduled in the future to give updates to the community about our progress, and to seek additional input.

The Selectmen have overall responsibility for overseeing the budget.

The Conservation Commission has received confirmation from Julie LaBranche at the Rockingham Planning Commission that she is available to provide technical assistance we need to accomplish our "plan for a plan" strategy supported by this grant.
