KNOW ALL MEN BY THESE PRESENTS, That Lewis Builders, Inc., a

New Hampshire corporation with offices at 54 Sawyer Avenue, Town of Atkinson, County of Rockingham, State of New Hampshire, for consideration paid, GRANTS TO the Town of Atkinson, a municipal corporation with offices at Academy Avenue, Town of Atkinson, County of Rockingham, State of New Hampshire with QUITCLAIM COVENANTS, the following five (5) parcels of land hereinafter described situated in the Town of Atkinson, County of

PARCEL 1: This is Map 12 Lot 12, backland behind the Chadwick parcel

Rockingham, State of New Hampshire:

The tract of land we own near the Pope Road, so called, in said Atkinson, Rockingham County, New Hampshire, believed to be Map 12, Parcel 12, of the Atkinson Tax Assessors' Map as in effect December, 1992, containing two (2) acres, more or less, bounded and described as follows:

Beginning at a stake and stones near Pats Rock, so called, Southwesterly from Pope Road; thence running Westerly by land formerly of Isaac R. Hovey to land formerly of Sarah L. Nesmith, now or formerly, and by land now or formerly of the heirs of George Poor; thence running North 89° Bast by said Poor Land, 50 rods and 5 links to a stake and stones at land now or formerly of Isaac R.
